## Elements of clarity

Start most sentences **with the subject** (avoid using a passive)

Avoid using dependent clauses (wh-clauses which, who, where and when clauses)

Avoid using complex sentences (if necessary, **break up a complex sentence** into two or even three simpler)

Keep subjects and verbs close together

Keep single verbs with multiple subjects, use single subjects with multiple verbs

Choose **positive** rather than a **negative construction**

Avoid using contractions (not: don't, but do not, not won't, but will not)

End sentences with a Bang not a whimper

Avoid using superfluous expression

### Elements of accuracy

- Make your subjects **definitely clear actors**
- Make your verbs **definitely clear actions**
- Eliminate **weak verbs** as much as possible and use only *the strong* ones

### Elements of cohesion

- Use linkage
- Use elegant variation
- Use cross- reference
- Use linking adverbials

### THE ORDER OF STEPS :

- The first two elements (TAXES structure, and the introduction) represents units of composition
- The second three elements represent the units of style
- Please make sure that your TAXES structure and **INTRODUCTION** is firstly completed
- At the second midterm, I will ask that you label each sentence by T) A) X) E0
- **Then** work out the elements of style

- As previously (in the first midterm), the assignment bears 4 points in total
- The additional elements of composition – **TAXES structure + INTRODUCTION** (bear one point respectively). 1 point in total
- Elements of style bear 1 pt respectively (1 + 1 + 1 = 3)
- **Clarity** - 1 pt
- **Accuracy** – 1 pt
- **Linkage** – 1pt
- 

#### Suggestion about the preparation of your essay

- It generally does not matter which of the criterion you will fulfill the first, and which the next one
- It is up to your choice. If I were you, I would first complete the Clarity part **and leave the Linkage-transition part to be the last one** (the principal reason being that students are often found struggling with the clarity part). Yet it is up to you.
- What really matters is that each requirement is done in full. Thus, do not skip over to the accuracy part or the transition part, if you are not completely certain that you have already not done the clarity part and vice versa

#### Why is this order important to follow and stick to?

- An explanation: it is very difficult to establish the accuracy of style without first maintaining the TAXES structure
